5. Delivery

Supplies are normally accepted on all working days from 9:30 A M to 6:00 PM except on Saturday, Sunday, and other public holidays.
- **5.2** All the perishables/hazardous item(s) shall be opened in the presence of the r epresentative of the bidder and the user.
- **5.3** In case of perishables, or hazardous consumables, the consent of the user m ust be obtained before the execution of the supply so that necessary precaution s shall be taken for their effective use. Part delivery will not be accepted
