1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility

for exemption must be uploaded for evaluation by the buyer.

- 2. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 2. The period of annual contract shall be from 1 year from the date of issuance of order.
- 3. The bidder must have valid GST Number and PAN card.
- 4. Place of delivery/service shall be ICMR NITM and the bidder must have Service centre/ Workshop in Karnataka state. (Proof of the same such address shall be enclosed.)
- 5. The bidder shall be authorized by the concerned brand Kent and upload the OEM certificate.
- 6. The Job shall be entrusted on the basis on "As is where is"
- 7. The bidder possessing at least three consecutive year work experience in "Annual Maintenance" Contract of Inbuilt RO cooler water machines. The bidder shall submit copy of work orders and performance certificate issued by the concerned organizations as document in support of the experience.
- 8. The office will award the contract to the successful bidder whose bid has be en determined to be substantially responsive and has been determined as lowe st evaluated bid, provided further that the bid is determined to be qualified to p erform the contract satisfactorily.
- 9. Director ICMR NITM reserves the right to increase or decrease the quantity of items under AMC.
- 10. Payment of AMC charges will be made on quarterly basis on submission of the bill and duly certified by technical officer of ICMR NITM
- 11. All certificates and documents as required in the bid shall be duly authentic ated and stamped.
- 12. The firm should ensure appropriate payment and other dues to the workers as applicable by the rules of Government.
- 13. The bidder entering into the AMC, shall depute qualified and experience me chanics for upkeep and maintenance of the Inbuilt RO cooler water machines wi thin stipulated time
- 14. The maintenance/servicing include service of all machines, periodical preve ntive maintenance, and overhauling of all machines and all repairs and replace ment of all kinds of Filters, Pre- filter candle, Compressor, Thermostat, Transfor mer, Relay, Carbon, Worn out parts, Rubber pipe, Screw/nut bolts etc. as well as cleaning of water tanks once in a month to maintain optimum TDS.
- 15. The spare parts used for replacement shall be procured from the authorized dealer/service centre of same make/quality as installed in new machine with wa rranty or guarantee as per manufacturer. The original bills/vouchers of purchas e of spare parts are attached with the quarterly payment claims as a proof of its genuineness.
- 16. Any financial loss caused due to damage of any office property by the contractor would be deducted from the bills payable to him.
- 17. The Service Level Agreement (SLA) as specified in the bid document shall be strictly followed by the selected service provider. Any deviation or non-compliance with the SLA terms, including response time, resolution time, preventive

maintenance, spare part availability, uptime commitment, and penalties, will le ad to appropriate deductions, penalties, or contract termination as per the defin ed terms. The buyer reserves the right to enforce all SLA clauses strictly withou t any relaxation.

- 18. The firm shall have to attend all complaints within stipulated time of 24 h ours of receipt of complaint. Thereafter, the delay in attending complaint shall attract a levy of compensation at the rate of Rs.500/- per day& per Machin e subject to a maximum of Rs.2500/- against the complaint. Thus after 5 day s the office shall have the right to get the complaint rectified on his own through any other agency and the amount shall be recovered from the concerned agency.
- 19. No Manpower and support will be provided for transportation or shifting of units from one place to another.
- 20. Whenever a machine or any part thereof needs to be taken out by the m echanic for maintenance/repair to the workshop, necessary permission must be obtained and no extra charges will be paid to this work. Units taken out of the Office premises for the service at workshop shall be returned at the earli est & in any case, within a week time.
- 21. If the bidder fails to commence services under the AMC as scheduled or t o deliver the services ordered to him within the period stipulated in the contr act, Office reserves right to Cancel the contract in whole or in part for the inc omplete /balance works/services. If the office decides to cancel the contract on account of the default or unsatisfactory services, the work shall be got do ne at the risk and cost of the bidder.
- 22. No increase in amount shall be considered at all during the full period of AMC exempt for revision in any taxes as per Government policy.
- 23. The firm should ensure the necessary safety of the workers while working in the office.
- 24. The office shall not be responsible in respect of any injury caused to the workers of the Bidder. It will be the sole responsibility of the Bidder.
- 25. The Contractor shall personally be responsible for the conduct of his staff and in case of any complaint against any staff; Contractor will be under oblig ation to change the worker when instructed by authority. The contractor shall observe all the laws and will be responsible for any prosecution or liability arising from breach of any of those laws. The office will not hold any r esponsibility with regard to staff on the role of the contractor what soever.
- 26. Director ICMR NITM reserves the right to terminate the contract at any p oint of time after giving 07 days' notice during the tenure contract in case of continued non- performance and inability to meet service requirements, or if the contractor dishonours the contract. The decision of Director ICMR NITM s hall be final and binding upon the contractor.
- 27. Director ICMR NITM reserves the right to extend the contract for two mor e year that if the services are satisfactory and cost-efficient.
- 28. Director ICMR NITM reserves the right to accept or reject any bid without assigning any reason.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
