The vehicles are to be disposed on "AS IS WHERE IS BASIS" located at single place. The vehicles can be inspected from 23.6.2022 to 12.7.2022 between 03.00 PM to 06.00 PM on any working days. Institute remains closed on Saturday & Sunday.

Above mentioned four wheelers vehicle registered with Regional Transport Authority (RTO), Belagavi. Prior to this, Tata Sumo (Ambulance) registered with RTO, Mumbai, Maharashtra, subsequently in the year 2010 the vehicle transferred to RTO, Belagavi.

Mahindra Marshal Jeep registered with RTO Uthagamandalam (TN) subsequently in the year 2006 the vehicle was transferred to RTO, Belagavi.

Queries, if any, may be raised at the time of vehicle inspection only, No queries will be entertained after the submission of bids.

- 1. <u>GST</u>: The Bidder shall submit GST registration certificate & copy of PAN duly attested. Tenders received without valid GST registration certificate will be rejected. Government levies/taxes as applicable on scrap/ unserviceable/obsolete material /equipment etc will be borne by the bidder.
- 2. Earnest Money Deposit (EMD)/Bid Security:
 - a. The bid documents may be submitted along with EMD amounting to Rs. 3,000/-(Rupees Three thousand only) in form of Demand Draft only in favor of "Director, ICMR NITM" payable at Belagavi must be submitted in original. The EMD should be valid for a period of 120 days. This amount shall not be adjusted with the offered value
 - b. Bids without EMD or lesser amount will be summarily rejected. The submission of EMD is compulsory for all the bidders and no exemption will be granted for submission of EMD in any case.
 - c. EMD will be forfeited if the bidder opts to withdraw after the submission of the bids and/or tenders is processed.
 - d. EMD of successful bidders shall be returned after payment of bid amount and lifting of the vehicles from the premises. In case, the material is not lifted within the prescribed time, the EMD will be forfeited.
 - e. The EMD of unsuccessful bidders will be returned to them without any interest whatsoever within 30 working days after the award of contract to highest bidder.

- 3. Successful Bidder will be required to submit the bid price in form of Demand Draft only in favour of "<u>Director, ICMR NITM</u>" payable at Belagavi within 10 days after the finalization of auction/award of contract.
- 4. After depositing of the bid amount, the bidder shall lift/remove the disposal vehicles within a period of 5 working days from site. If the disposal items are not lifted/removed within the said period, the Institute shall not be responsible for its safe custody and also the tenderer/bidder shall not have right or claim for the disposal items and EMD/bid amount deposited shall be forfeited, The goods shall be lifted at the risk and responsibility of the tenderer, The Institute will not be responsible in any way under any law once auction of the materials has taken place.
- 5. Vehicles should be inspected by the intending purchaser before making an offer and items will be sold on "ÁS IS WHERE IS BASIS", the auctioneer is not responsible for its quantity, quality, size and measurements etc of the goods. Vehicles are sold on the assumption that the bidder has inspected the items prior bidding and know what they are buying. Once an offer is accepted purchaser will have to take the delivery of the goods not withstanding all the faults and flaws, if any, in the condition or description etc. of the goods irrespective of whether it was actually inspected or not. No selection or sorting or whatsoever of the goods will be allowed.
- 6. Resale will not be recognized & delivery orders will be made in the same name of actual bidders only. The original, purchaser, whose offer has been accepted, wish to take delivery of the goods through a representative; he must authorize representative by a letter of authority. Delivery by proxy will be at the purchaser's own responsibility and risk. No claim or damage or losses of any kind will be entertained any account whatsoever.
- 7. The Institute reserves the right to reject all or any tender without assigning any reason. The decision of the Director in this behalf and all other matters relating to the disposal shall be final and binding on both the parties.
- 8. The bid of any bidder who has not complied with one or more of the conditions prescribed is liable to rejected.
- 9. The bids shall be scrutinized/ verified by the institute in terms of the tender and subsequently the eligible PRICE BIDS shall be opened. The bidder, who has quoted highest amount, shall be selected as H-1 bidder.

- 10. If two or more bidders have quoted the same price, H-1 bidder will be chosen by way of draw.
