## ADDENDUM TO THE ADVERTISEMENT NOTIFICATION OF UDC POST AT ICMR - NITM

Reference: Vacancy notification no. NITM/Admn./01/2023 dated 4-10-2023.

This addendum serves to provide further clarification and additional details regarding the recruitment process for the post of Upper Division Clerk (UDC) (1-OBC) at ICMR-NITM, Belagavi. The following points outline the key aspects of the updated process:

- 1) <u>Screening Criteria:</u> Applications are screened based on the minimum educational qualifications, age limit, and relevant work experience as specified in the original notification. Only candidates meeting all eligibility criteria will proceed to the next stages of the selection process. The revised list of Eligible and Not Eligible candidate is attached in Annexure I and Annexure II.
- II) <u>Selection Procedure:</u> Computer Based online screening for the post of Upper Division Clerk will be held consisting of two tiers examinations [(Tier -1: A Computer Based Test of MCQs and Tier-2: Computer Skill Test) (CST)] and Post Qualification Experience (PQE)

a)	<u>Computer Based Test (CBT)</u> : CBT of MCQ type will be with a total of 100 questions

\* The CBT carries negative marking; 1 mark shall be awarded for each correct answer and 0.25 marks shall be deducted for every incorrect answer. Questions from the subject matter will be of a level commensurate with the essential qualification.

The minimum essential pass marks to be obtained by a candidate in a CBT for consideration in the merit list for the post of Upper Division Clerk is 50 Marks.

b) <u>Computer Skill Test</u> (CST): CST for the post of Upper Division Clerk will be of qualifying nature as below:

c) Post Qualification Experience (PQE) (Maximum 5 marks) - Up to 5 marks will be accorded to candidates who possess 'Post Qualification Experience' in any Government recognized or approved or registered organization. The marks for experience will be accorded as below:

Post Qualification Experience weightage table			
Relevant Experience	Marks		
>1 and up to 2 years	1		
>2 and < 4 years	2		
>4 and < 6 years	3		
>6 and < 8 years	4		
>= 8 years	5		

These marks (5%) will be added to weighted (95%) of CBT marks for CBT passed & CST qualified candidates.

### IMPORTANT NOTE

- The CBT and Post Qualification Experience will carry a cumulative weightage of 100% and the computer skill test is qualifying in nature.
- The Candidates based on their performance in CBT shall be called for Computer Skill Test in 1:10 ratio (10 candidates for every vacancy in respective category)
- The Scores of candidates in CBT will be considered for the final merit list only if the candidate qualifies the computer skill test.
- The cut-off marks of the skill test will be decided by ICMR-NITM in relation to the number of vacancies.
- The CBT scores will be converted to 95% and up to a maximum of 5 marks will be accorded for Post Qualification Experience. The sum arrived will have a weightage of 100% and shall be the final scores, from which the final merit list shall be prepared
